### **Subject to Contract/Contract Denied**

**Re: COMPLIANCE WITH S96 (PART V) PLANNING AND DEVELOPMENT ACT, 2000 AS AMENDED (“THE ACT”) APPLICATION BY MARINA QUARTER LIMITED FOR PLANNING PERMISSION ON THE FORMER FORD DISTRIBUTION SITE, FRONTING ONTO CENTRE PARK ROAD, BALLINTEMPLE, CORK.**

I write to confirm the applicant's proposal to comply with the requirements of Section 96 (Part V) of the Act in relation to the above development.

Please note that the contents of this letter are purely indicative and are intended to provide a reasonable estimate of the costs and values of the units based on construction costs and values prevailing at the time of the application. Please also note that the information set out herewith is purely for the purposes of facilitating the making of a planning application and will ultimately be subject to possible amendment and formal agreement with Cork City Council on submission of the commencement notice in relation to the development of the site.

The financial data contained herein is provided to the level of detail commensurate with this stage of the Part V process having regard to Circular Letter 10/2015.

We note under the recent Amendment to the Act and its accompanying Regulations that the ultimate agreement with regard to Part V is dependent a) upon receipt of a final grant of permission and b) upon a site value at the time the Permission is granted; neither of which can be available at this time.

### **Preferred Option to Comply with Part V**

Without prejudice to the above, it is proposed to provide 10% of future permitted units on site under order to comply with Part V.

### **Estimated Cost to the Local Authority**

The overall estimated cost to the Local Authority at this time is €6,677,051.88.

### **Identification of Units**

In the context of this planning application, it is therefore proposed to provide 18 no. dwellings on the site in total to comply with Part V of the Act. It is proposed to provide:
